## IS HEREBY AMENDED, REPLACED AND/OR DELETED AND REPLACED WITH THE FOLLOWING:

### 10.5 Leasing of Residential Units.

An Owner of a Residential Unit will have the right to lease or rent his Unit; provided, however, that all leases and rental contracts will be in writing and require the lessee to abide by all conditions and restrictions placed on the use and occupancy of the Residential Unit and the Common Area by the Regime Documents. No Owner shall lease a Residential Unit, or any portion of a Residential Unit for any rental term less than thirty (30) consecutive days. This restriction shall be effective as to all Owners and Residential Units on **December 31**, 2023, regardless of the date of acquisition.

The Board of Directors will have the right to approve the form of all leases and rental contracts if it elects to do so. Occupancy by a tenant or renter pursuant to an approved form of lease or rental contract is subject to continuing approval of the Board. The Board may remove its approval of the form of a lease or rental contract at any time for any violation by any tenant or renter of the Governing Documents of the Association requiring the termination of the tenancy. Lease, rental, or license agreements with respect to Non-Residential Units shall not be subject to this restriction or to the approval of the Board as provided herein.
